#### 4.2 GENERAL ADVICE:

#### SECTION 5. FIRE FIGHTING MEASURES

- 6.1 SPILL AND LEAK RESPONSE AND ENVIRONMENTAL PRECAUTIONS: Uncontrolled releases should be responded to by trained personnel using pre-planned procedures. #### SECTION 7. HANDLING AND STORAGE

### 7.1 PRECAUTIONS FOR SAFE HANDLING:

Isolate from oxidizers, heat, & open flame. Use only with adequate ventilation. Avoid breathing of vapor or spray mist. Do not get in eyes, on skin or clothing. Consult Safety Equipment Supplier. Wear goggles, face shield, gloves, apron & footwear impervious to material. Wash clothing before reuse. Avoid free fall of liquid. Ground containers when transferring. Do not flame cut, braze, or weld. Empty container very hazardous! Continue all label precautions! NEVER pour water into this substance. When dissolving or diluting, always add it slowly to the water.

7.2 CONDITIONS FOR SAFE STORAGE, INCLUDING ANY INCOMPATIBILITIES:

#### **SECTION 10. STABILITY & REACTIVITY**

#### 10.1 REACTIVITY & CHEMICAL STABILITY:

Stable under normal conditions, no hazardous reactions when kept from incompatibles.

10.2 POSSIBILITY OF HAZARDOUS REACTIONS & CONDITIONS TO AVOID: Isolate from oxidizers, heat, & open flame.

### 10.3 INCOMPATIBLE MATERIALS:

Reacts violently with fire extinguishers containing water. The substance is a base, reacts violently with acids and is corrosive. Reacts with water generating sufficient heat to ignite combustible materials. Reacts violently with strong oxidants, strong acids, causing fire & explosion hazard.
